- Will need to arrive at the Delivery Site during the appointed time period.
- Will need to bring enough containers to hold the purchased fish. Five-gallon buckets work well. Each container must have an unscented poly liner (30 gallon trash bag). THE BAGS ARE NECESSARY TO HOLD OXYGEN TO KEEP THE FISH ALIVE DURING TRANSPORT. DO NOT use a lid; use a twist tie or twine to close the bag. Each container shall be filled with customer pond water, but just one-third full. General rule of thumb: one container per 100 small fish, one container per 1,000 minnows, one container per 2-3 amurs and koi.
- Customers are requested to help with the loading and unloading of their containers into their vehicle at the Delivery Site. This will help expedite the entire delivery process.
